# Student Learning Outcomes are Central to Accreditation

#### Did you know?

- Accreditation is the vehicle through which SDCE renews its license to continue to serve our students and community with excellence.
- The Mid-term Accreditation Progress
  Report is being finalized with a virtual
  one-day progress visit scheduled for April
  29th 2021.
- Student Learning Outcomes (SLO) are at the center of accreditation and are listed first (1st) among the ten criteria used for Postsecondary Schools. See the Accrediting Commission for Schools (ACS) Western Association of Schools and Colleges (WASC) Criteria below:

ACS WASC conducts a value-added evaluation and looks for how schools **add value** through **SLOs.** Specifically, the team wants to know how we add value by ...

- Increasing what students **know**
- Increasing what students can do
- Improving how students feel

  - $\circ \rightarrow About others$
  - $\circ \rightarrow About learning$



Learning Outcomes (SLOs) are the end products of a course and describe what students should know, think, and do as a result of the teaching.

Remember Your ABCs of SLOs!

- ↓ Ideally each course should have at least 2 BUT no more than 4 or 5 measurable (demonstrable/observable) student learning outcome statements.
- **Each** course should have the EXACT same learning outcomes regardless of who teaches the course to help ensure consistency of outcomes for all students.
- Use verbs from new Bloom's Taxonomy to describe what successful students do.
- **↓** Consider using/describing the course capstone project, or a couple of its parts, as the SLO(s).
- Using SLOs and their assessment as exit criteria (for certificates & grades) is a best practice and ensures that students have mastered the competencies/content standards prior to course/program completion.

The focus of the SLO Coordinator and SLO Task Force is the improvement of teaching and learning through the understanding, use and assessment of learning outcomes, including the following best practices:

- transparent assignments
- Backwards Design/Understanding by Design
- aligning grades/certificates to SLOs
- mapping SLOs to program and institutional outcomes
- ongoing faculty trainings aimed at institutionalizing a student assessment process

The SLO Taskforce meets on the second Wednesday of the month during 2020-21. The Task Force, chaired by the SLO Coordinator, helps to inform and review the SLO process so that it consistently supports faculty and fosters student success. SLOs are the purview of faculty. Therefore, it is important that programs be represented on the taskforce and have input on the institutional effectiveness efforts regarding SLOs:

- Implementation of SLO software system
- Student Learning Outcomes assessment
- Professional Development as it relates to student learning
